

## St. Peter's Annual Congregational Meeting Minutes-Sunday, January 28, 2024

The 143rd Annual St. Peter's Evangelical UCC Congregational Meeting was called to order by Sherry Coker at 11:20 am. The 2023 Annual Meeting Minutes were approved as read by Amber Tinsley. Sherry thanked Amber for her time this year as church board secretary. The 2023 Financial Report was presented by Danny Hutter. Danny summarized the report for the congregation. There were no questions from the members of the congregation and the report was approved as read. Sherry thanked Danny for his service as church board treasurer this past year.

Audit Report: Fred Zell reported that all financial records for the church and the cemetery are in order with no discrepancies found. He expressed his thanks to Danny Hutter for his service. Sherry thanked the auditing committee for their work. Sherry also expressed a need to form a maintenance committee to help with repairs and maintenance for the church and rental properties.

Pastor's Report: Pastor Brittany reported some statistics including number of home and hospital visits, baptisms, funerals, regular services and special services. Sherry thanked Pastor Brittany for her efforts this year.

## Organization Reports:

1. Ladies' Friendship Guild: Charlene Rumley reported that the Guild continues to support church members with gifts, flowers, and cards as needed. They served a funeral dinner for Judy Rauch, observed the guild anniversary dinner at the home of Pat Ware and gave a donation of \$170 in appreciation for Pat hosting the meal, sent a \$243 donation to the Emmaus Home at Thanksgiving, gave

Norma Wagemann an angel when she was in the hospital, sent Convoy of Hope a \$100 check at Christmas, sent Paw Packs and Ministerial alliance each a \$75 check, and sent the Children's Home a check for \$350 at Christmas. The ladies guild did a lot of work in the kitchen and basement to clean and organize the church. They also still provide needed cleaning supplies and paper goods. They currently have a balance of \$4,011.61 as of January 1st.

- 2. Sunday School: David Rauch reported a balance of \$433.03 left over from the old sausage suppers.
- 3. Adult Sunday School: Chris Rauch reported a balance of \$2,087.67. These funds are used to buy study materials, Christmas Candy, and help with the youth group as needed. Denise Hampton encouraged others to come join the class with current attendance of around 10 members.
- 4. Youth Group Report: Activities are currently being restarted with hopes of more events in the future.
- 5. Board Report: Sherry thanked Pastor Brittany for how hard she works and how much she achieves in her part time hours. She encouraged all of the congregation members to think about the role of the pastor and what tasks might be able to be performed by us instead of in the pastor's limited time. She reminded us that we were a small but blessed church with many resources especially considering the size of our congregation.

Sherry thanked the members of this year's church board, particularly Amber Tinsley and David Rauch who are leaving the board, for their time and hard work. She also thanked all congregation members who contributed to the work of the church in any way.

Board Election: The board has the following positions available and makes the following recommendations:

- 1. Chris Rauch, Trustee (3-year term)
- 2. Mary Kay Kastendieck, Secretary
- 3. Danny Hutter, Treasurer
- 4. Denise Hampton, Ladies' Friendship Guild Representative

Motion was made for nominations to cease and elect the slate of officers by acclamation by Luella

Thomas. Seconded by Diane Zell. Motion carried.

Amber Tinsley thanked Sherry Coker for her service as President of the church board.

## Because Jesus Said So....

One intriguing person in the Passion account is the thief on the cross whom Jesus promised a same-day entrance to paradise (see Luke 23:43). Pastor and radio host Alistair Begg says he can't wait to meet that man and ask how everything unfolded. "You were cussing [Jesus] out with your friend," Begg says. "You've never been in a Bible study. You've never been baptized. You didn't know a thing about church membership, and yet you made it!"

In a sermon, Begg pictures an imaginary angel at the pearly gates, growing frustrated during the sinful thief's entrance interview. After receiving no clear answers from the thief about doctrines such as justification, the angel finally asks, "On what basis are you here?" The thief simply replies, "The man on the middle cross said I can come."
